Instructing a Valuer

Thank you for your enquiry about buying more shares (known as Staircasing).

The first stage of Staircasing involves instructing a Valuer to value your home. To determine the value of your home you must instruct an independent Valuer, qualified through the Royal Institution of Chartered Surveyors (RICS).

We have a panel of Valuers for you to choose from below. The Valuers on our panel are independent of Guinness and are qualified by the Royal Institution of Chartered Surveyors. They have a wealth of experience in valuing homes and can offer preferred rates to Guinness customers and residents.

We have included their contact details should you wish to contact them with any queries, including their fees. Please remember to inform them that you are living in a Guinness property so they can confirm any preferential rates.

Instructing your own independent surveyor

You are able to instruct an independent RICS/FRICS registered surveyor of your choice or you can select a surveyor from our panel by completing the valuation request form.

If you would like to use your own surveyor then they must meet the following criteria:

- The Valuer needs to be independent and cannot be associated with any estate agents.
- The Valuer must not be related to you.
- The Valuer must not be employed by any bank/building society.

- The Valuer must be registered with a recognised qualification of FRICS, MRICS or RICS.
- Guinness will require a copy of the valuation report; this should be valid for a period of three months. (and should be valid until completion takes place)
- The report must include at least three comparable properties used to determine the value.
- The report must also state that Guinness can use the contents of the valuation report.
- The Valuer will need to be informed of the remaining length of your lease and take this into consideration when valuing the property. The report should be annotated as such, to reflect this.

On receipt of your own independent valuation please arrange for a copy of the report to be sent to us along with the Staircasing Application Form. The valuation must state that it is valid for three months, and be signed by your Valuer.
