- Legal action is being taken against you or a member of your household.
- You have an ongoing disrepair claim with us.
- The property is not suitable for the needs of the remaining tenant. We will discuss alternative arrangements with you.

Whether or not to approve this application will be at our discretion.

Will you rehouse me if I give up the tenancy?

No, once you have given up the tenancy you will need to find your own alternative accommodation. We would advise you speak to the housing department at your local council before making this application.


